### COZY LEGACY, LLC. PRIVACY POLICY:

COZY LEGACY, LLC (the "Company") is committed to maintaining robust privacy protections for its users. Our Privacy Policy is designed to help you understand how we collect, use and safeguard the information you provide to us and to assist you in making informed decisions when using our Service.

For purposes of this Agreement, "Site" refers to the Company's website, which can be accessed at <a href="www.cozylegacy.com">www.cozylegacy.com</a>. Our "Service" refers to the Company's services accessed via the Site, in which users can find content creators who specialize in marketing and/or entertainment services. ### I. INFORMATION WE COLLECT

We collect "Non-Personal Information" and "Personal Information." **Non-Personal Information** includes information that cannot be used to personally identify you, such as anonymous usage data, general demographic information we may collect, referring/exit pages and URLs, platform types, preferences you submit and preferences that are generated based on the data you submit and number of clicks. **Personal Information** includes your name, address (if you run a business), contact information (number, email, etc.), photos you post, personal blogs, business links, social media links, calendar of events, etc. If you book services with our team, information like debit/credit card information, crypto currency assets, etc is to be used in legal manners only. ## 1. Information collected via Technology

For example, we store a persistent cookie to see what pages you are on while you are on the CozyLegacy.com website. We only store permanent cookies when blogging about our team, news in the media, social media links and what is posted on those social media pages through the Cozy Legacy brand and it's team members.

# 2. Information you provide us by registering for an account

In addition to the information provided automatically by your browser when you visit the Site, to become a subscriber to the Service you will need to create a personal profile. ### II. HOW WE USE AND SHARE INFORMATION

### Personal Information:

If our information practices change at any time in the future, we will post the policy changes to the Site so that you may opt out of the new information practices. We suggest that you check the Site periodically if you are concerned about how your information is used.

### III. HOW WE PROTECT INFORMATION

We implement security measures designed to protect your information from unauthorized access. Your account is protected by your account password and we urge you to take steps to keep your personal information safe by not disclosing your password and by logging out of your account after each use. We further protect your information from potential security breaches by implementing certain technological security measures including encryption, firewalls and secure socket layer technology.
